Path of Pipeline through Northern Chester County

Dear Ms. Kanouff:

On November 10, 2008, members of the Boards of Supervisors of West Pikeland Township, East Nantmeal Township and West Vincent Township, together with representatives of the environmental and land preservation community including Green Valleys Association, the Charlestown Township Open Space Commission and French and Pickering Creeks Conservation Trust, and approximately 50 residents met to discuss the proposed path of the new high-pressure natural gas pipeline which Dominion is proposing to extend through the Townships.

The Townships had received a copy of the proposed route through Pennsylvania Senator Andrew Dinniman's office. The proposed route crosses highly sensitive wetlands, exceptional value streams (as certified by the Pennsylvania Department of Environmental Resources), and cuts through lands preserved from development (some of which were preserved through the use of public funds), a number of Federal historic districts and through or near critical historic resources from the 1700 and 1800s. The overwhelming sentiment at the meeting was that there must be a more appropriate route for the pipeline to take.

The above-mentioned Townships therefore hereby request that a meeting be set up as soon as possible with the appropriate representatives of Dominion Transmission to discuss these concerns and to hopefully begin a process which would ultimately result in the most appropriate route through northern Chester County.




